Chet Ram) duly registered on 19/03/2008 (date) at Registration No. 3,188 In additional book no. 1, volume no. 1422 on page 99 to 133 (complete details of registration) in the office of Sub Registrar VI B, New Delhi (details of registration office). It is certified that the said entire land comprises of a single plot of land.

It is further stated that the owner of the land has leased the said land to MATA RISHALO DEVI CHERITABLE TRUST (REGD.)
